- Develop and implement a content review schedule to ensure regular updates of all educational materials.

Topic and Curriculum Development

- Research and identify emerging trends, gaps, and high-priority topics in small animal veterinary medicine
- Collaborate with education committees to propose new course modules, webinars, or resources based on learner feedback, sector needs, and evidence-based practice.
- Monitor competitor offerings to ensure BSAVA remains a leader in innovative education.
